Why Programmatic CDM?

- Asymmetries in participation:
 - some regions and countries thus far not benefiting at all from CDM – e.g. The Pacific
 - Small projects and some types of projects not benefiting
- In some regions there is a limited number of “typical” projects per country
 - Smaller sectors and projects
 - Low CER volume per activity
 - High transaction costs
- Programmatic CDM aims to facilitate smaller projects in smaller markets

Programmatic CDM (p-CDM): Glossary

- Multiple activities under one “Programme”
- **PoA:** Programme of Activities – a voluntary coordinated action, policy or programme
- **CPA:** CDM Programme Activity under a PoA – an unlimited number of CPAs can be conducted under one PoA
- Each CPA treated as a regular CDM project; but “easier” to register once PoA has been validated has been registered

CDM Executive Board actions

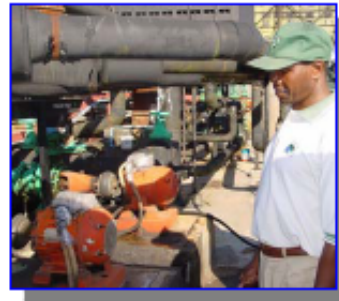
- Simplified procedures:
 - administrative levy halved
 - No fees from some PICs (LDCs – Samoa, Solomons, Vanuatu)
- New simpler rules for CDM projects from Small Island States e.g. additionality automatic for smaller RE and EE projects
 - Type I: RE under 5MW
 - Type II: EE under 20 GWh a year
 - Type III: projects under 20,000 tCO₂/year
- Possible for one PoA to use many methodologies
 - If combination has already been used before
 - If not, permission has to be requested to EB

CDM PoA or pCDM is suited to small-scale, dispersed activities

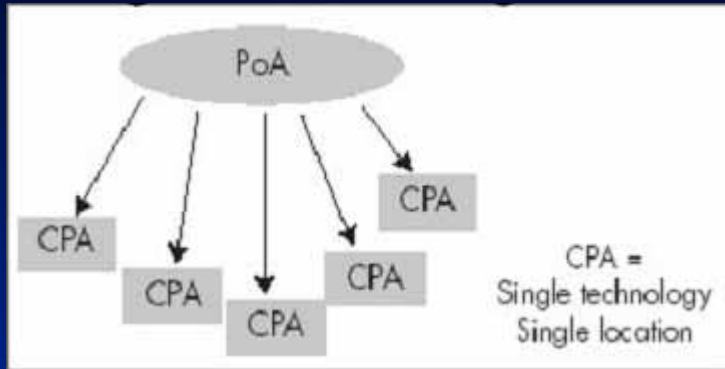

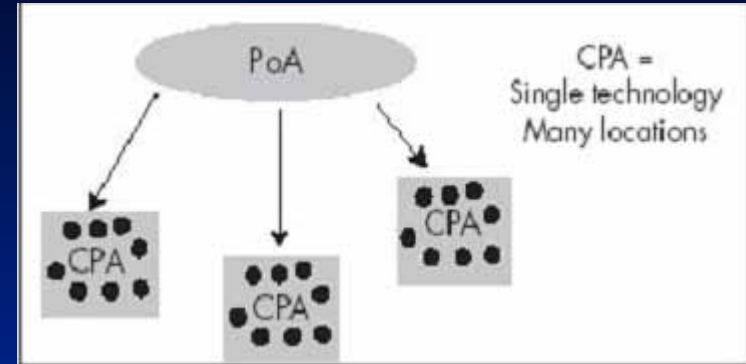

Single measure Single location Single measure Many locations

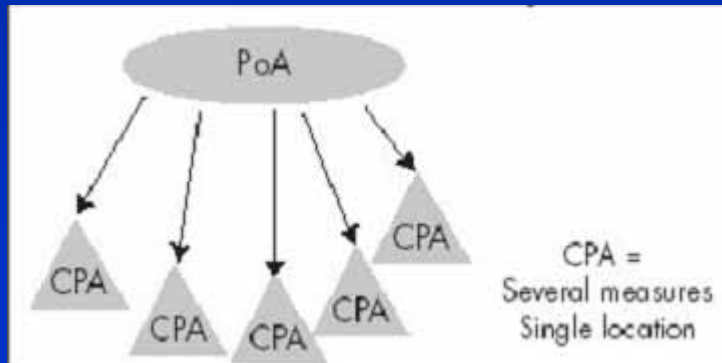


such as improved insulation in buildings

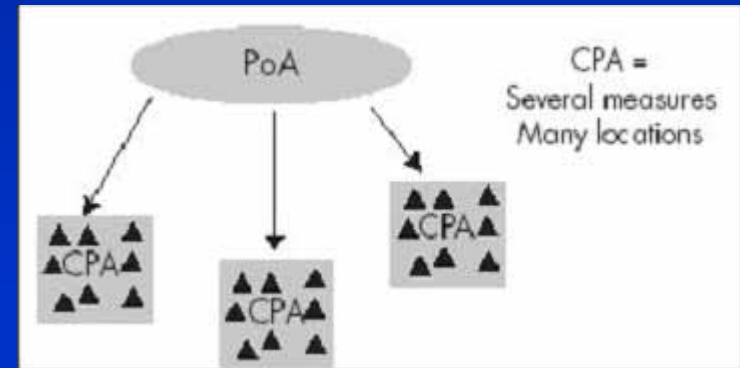


such as replacement of inefficient light bulbs in many locations

such as a set of EE measures applied to multiple boilers in same industry



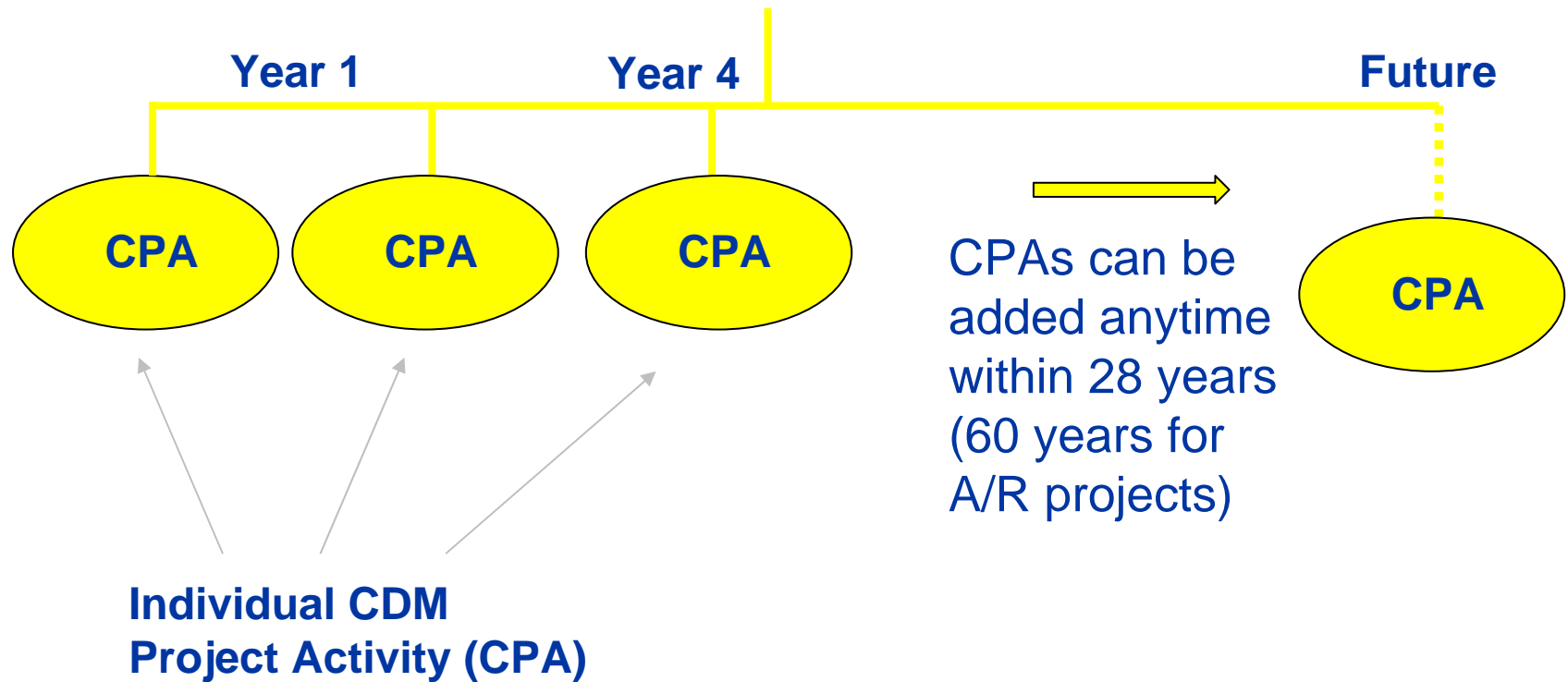
such as EE measures in a city or suburb

Programmatic CDM (p-CDM)

- A CPA can be included in a registered PoA any time (within 28 years for RE)
- One time registration fee – reduced transaction costs
- Fewer regulatory risks
- Different time scales and sizes allowed for CPAs
- More than one country can be included in the PoA – opportunity for the smaller PICs

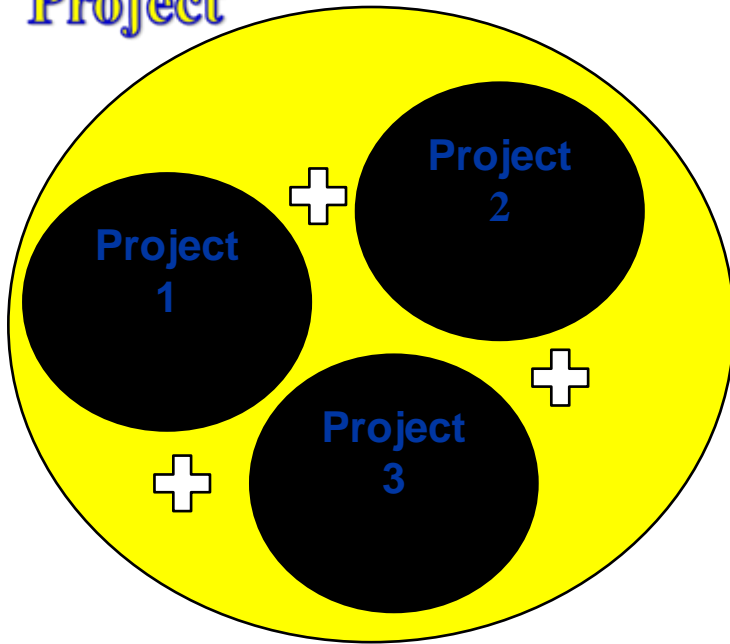
Visualising Programmatic CDM

CDM Programme of Activities (PoA)

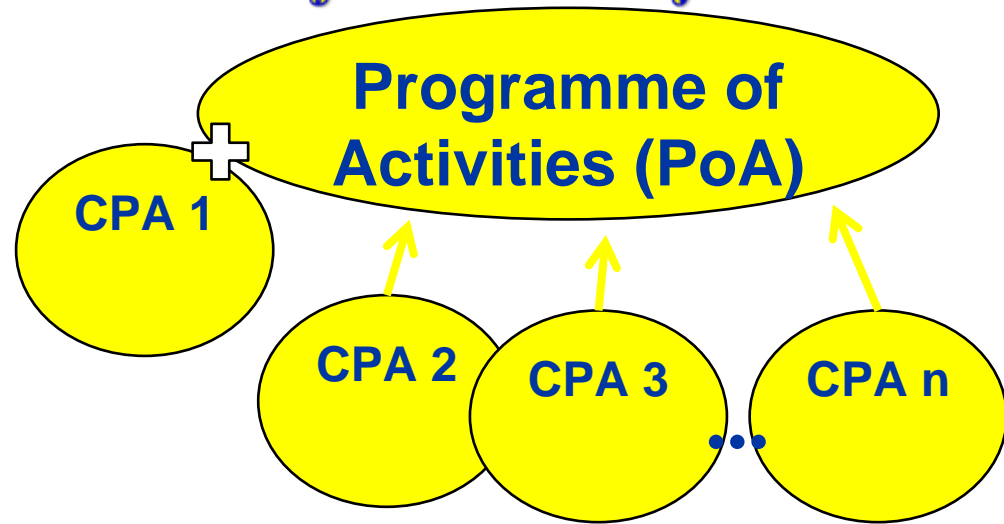


Difference between PoA and Bundling

**BUNDLING: 1 CDM
Project**



**PoA: 1 Programme +
Unlimited number of
Projects over 28 years**



- Bundling: requires all projects to be identified and quantified before registration

- PoA: Can register the programme framework plus just one CPA – the other CPAs can be registered later

pCDM – Modalities and Procedures

- **Wide range of activities to reduce GHG**
 - The programme is a deliberate effort to reduce emissions from multiple sites
 - The sites can be located within one or more cities, regions or countries
 - The DNA of each participating country must submit a Letter of Approval (LoA)

pCDM – Modalities and Procedures

➤ Coordinating/Managing Entity

- The programme is coordinated or managed by one entity (public or private)
- This entity does not necessarily achieve the reductions itself, but promotes others to do so
- The coordinating entity is responsible for making any arrangements for the distribution of CERs and for communicating with the Executive Board

pCDM – Modalities and Procedures

➤ Monitoring & Verification

- The total volume of emission reductions to be achieved by a PoA may not be known at the time of registration
- Each CPA is monitored according to the monitoring methodology that has been applied for the programme activity and specified in the monitoring plan
- In cases where there are many small emission reductions, statistically sound sampling procedures are permitted

pCDM – Modalities and Procedures

➤ Submission for Registration

- Programme of Activities Design Document (PoA-DD) - a special PDD format to be used for submitting and registering a programmatic CDM project
- CDM Programme Activity Design Document (CPA-DD) - a special PDD format to be used for the addition of every CPA to the registered programme
