## Welcome to the CDM Rulebook

### Current to EB 58 - Latest Developments

- The EB suspended the methodology AM001 with immediate effect while the Meth Panel conducts another review of the methodology. Methodology AM001 is applicable to project activities that destroy HFC-23 generated during the production of the refrigerant HFC-22. The EB is concerned that this type of project activity can create incentives for project developers to increase baseline emissions through increases in the production of HFC-22. The Executive Summary of the Meth Panel's Report on HFC-23 issues can be accessed [here](#).
- The EB adopted version 1 of the Procedure on performance monitoring of designated operational entities. A summary of the Procedure can be accessed [here](#).

The CDM Rulebook is the definitive online database of the CDM rules. It has been developed by Baker & McKenzie, with funding from eight donor organisations, and is now freely available to the public.

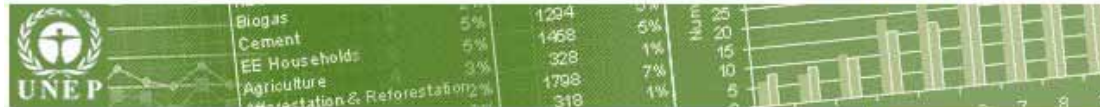

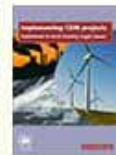
